## Health screening benefits

Our health screening benefit provides a payment if you, your covered spouse and your covered dependent child(ren) complete a health screening test. This benefit pays \$50 per screening, limited to 1 per calendar year.<sup>1</sup>

Your hospital indemnity insurance may include access to benefits that can help in certain scenarios, available on your first day of coverage.

### › Take your hospital indemnity coverage with you if you leave your job (also known as “Portability”)<sup>2</sup>

If your employment is terminated, you can continue your hospital indemnity insurance, and hospital indemnity insurance for your insured spouse and dependent children, on a direct-bill basis.

### › Support for your health care questions.

Through our Health Care Support program, you’ll have access to trained advocates and registered nurses to help you effectively navigate your health care plan and provide support for your questions and concerns.<sup>3</sup>
